THIRD AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR WANDERING CREEK

The undersigned, constituting the "Declarant" under the Declaration of Covenants, Conditions, Restrictions and Easements for Wandering Creek, which was filed of record with the Lancaster County, Nebraska Register of Deeds office on June 12, 2019, as Instrument No. 2019020431, as amended by the First Amendment to Declaration of Covenants, Conditions, Restrictions and Easements for Wandering Creek, which was filed of record with the Lancaster County, Nebraska Register of Deeds office on December 13, 2019, as Instrument No. 2019050713, and the Second Amendment to Declaration of Covenants, Conditions, Restrictions and Easements for Wandering Creek, which was filed of record with the Lancaster County, Nebraska Register of Deeds office on June 19, 2020 as Instrument No. 2020028324 (collectively the "Declaration"), does hereby, pursuant to Declarant's authority provided in Article VIII, Paragraph 4 of the Declaration, amends the Declaration as follows:

A. Article III, Paragraph 7 Fences is hereby amended and restated as follows:

- 7. <u>Fences</u>. Fencing shall be permitted on all Lots subject to the restrictions set forth herein. Fencing for all Nature Lots and the Townhome Lots in Wandering Creek 2nd and 3rd Additions must be constructed of black wrought iron or similar material. Fencing for Interior Lots and all other Townhome Lots must be constructed of (i) black wrought iron or similar material or (ii) wood board on board material. Stockade or chain link fences are strictly prohibited. Fencing shall not be constructed on any Lot closer to the street than the rear wall of the residence constructed upon such Lot. All fences must be submitted to the Declarant for review and approval prior to installation.
- B. All other terms and conditions of the Declaration, except as amended herein, remain in full force and effect. In the event of a conflict between the terms of this Amendment and the terms of the Declaration, the terms of this Amendment shall control. Capitalized terms used herein and not defined herein have the same meaning as in the Declaration.

C. This Amendment shall be filed of record with the Lancaster County Register of Deeds against the "Property" which is legally described on Exhibit "A" attached hereto and incorporated herein by this reference. Executed this 10 th day of November, 2020.
